Elections for New Leadership

At the very beginning of the year, WPA Military Section Officers launched elections for new leadership for the next triennium. Position Statement on Military Personnel and Veterans' Mental Health

We invited all members to participate in the initiative to prepare a Position Statement on Military Personnel and Veterans' Mental Health. This initiative was proposed by Prof. Thomas G. Schulze, WPA President-Elect.

The statement was discussed in the context of the current global conflict situation and its impact on the mental health of military personnel and veterans. Seven colleagues actively contributed to this effort, engaging in fruitful collaboration through correspondence and online meetings to discuss each topic.

After finalizing the draft, we initiated the official evaluation procedure with the WPA Executive Committee and shared the document with the Secretary of WPA Sections. By the end of 2024, we were awaiting the Executive Committee's response.

WPA World Congress of Psychiatry 2025

The WPA Sections were invited to propose State-of-the-Art Sessions for the upcoming WPA Congress in Prague, scheduled for October 5–8, 2025. The deadline for submissions was January 21, 2025.

We proposed two sessions:

- 1. Military Personnel and Veterans' Mental Health
- 2. Complex Posttraumatic Stress Disorder A New ICD-11 Category: State-of-the-Art Approach in

By the end of 2024, we were awaiting a response, hoping that at least one of these sessions would be accepted.
