Edmond Hsin-tung Pi, M.D. is currently serving his second term on the WPA Board as Zonal Representative for Zone 2 (USA). He is a Professor Emeritus of Clinical Psychiatry and the Behavioral Sciences at University of Southern California (USC) Keck School of Medicine, Los Angeles, California, USA. He is also a Clinical Professor, Department of Psychiatry and Biobehavioral Sciences at University of California Los Angeles (UCLA) David Geffen School of Medicine. Professor Pi has served on the Scientific Program Committee (SPC) of the American Psychiatric Association (APA) during the past 20 year, including Vice Chair of the SPC of 2019 and 2020 Annual Meetings of APA. He received the SPC Overachiever Award, APA Annual Meeting, 2019. Professor Pi served as the Chair of Scientific Committee of the 5th Pacific Rim College of Psychiatrists (PRCP) Scientific Meeting in 1991 and Chair of Scientific Program Committee of American College of Psychiatrists (ACP) Annual Meeting in 2013.

Professor Pi is a Distinguished Life Fellow of the APA, Emeritus Fellow of ACP, International Associate of Royal College of Psychiatrists, United Kingdom, and Honorary Member of Chinese Society of Psychiatry. He has been very active on both the national and international scenes in organized psychiatry in the past 30 years, including President of Association of Chinese American Psychiatrists, Vice President and Treasurer of Pacific Rim College of Psychiatrists, Chairperson of Committee of Asian American Psychiatrists, Representative of Asian-American Caucus, Chair and Vice-chair of seven Minority and Underrepresented (M/UR) Groups, and Member of the Assembly Executive Committee of APA. Among his many honors, he is the recipient of the 2009 Kun-Po Soo Award of APA for his significant

contributions toward understanding the impact and import of Asian cultural heritage in areas which have relevance in psychiatry. Professor Pi also received the 2018 Outstanding Achievement Award of Southern California Psychiatric Society for sustained clinical, educational, and administrative contributions in cross-cultural psychiatry, psychopharmacology, and organizational leadership at local, state, national and international levels.

Professor Pi has been consistently acknowledged as a valued educator and received many outstanding teacher's awards for his excellent teaching and clinical supervision. He previously served as Executive Vice Chair, Associate Chair for Clinical Affairs and Director of Psychiatric Residency Training Program and Psychiatric Clerkship for medical students at different medical schools in the US. Professor Pi is an accomplished researcher in the fields of clinical psychiatry and psychopharmacology (particularly ethnic, cross-cultural, and international/global aspects) with more than 150 publications including authorship in psychiatric textbooks. Professor Pi's expertise has been sought globally and has given numerous presentations and chaired sessions at both national and international scientific meetings. He has been invited by editorial board of journals and publishers to write articles and book chapters. Most recently, Professor Pi co-edited a book entitled "Education about Mental Health and Illness" with Drs. Marc H.M. Hermans and Chay-Hoon Tan, in Mental Health and Illness Worldwide Series edited by Professors Norman Sartorius and Ee Heok Kua, Springer, 2019.

Professor Pi has held many substantial and significant administrative positions in his career. The most significant non-academic position was serving as the Medical Director for the State of California, the most populous state in the United States, Department of Mental Health (DMH), which has oversight over a \$2 billion public mental health annual budget. Dr. Pi was the DMH's highest-level psychiatrist and was responsible for ensuring the development and implementation of statewide mental health treatment services. Professor Pi is a diplomate of the American Board of Psychiatry and Neurology in the specialty of Psychiatry (1980-Present) with added qualification in the subspecialty of Psychosomatic Medicine (2008-2018). Dr. Pi is listed among the Best Doctors in America and America's Top Doctors.
